GENERAL TERMS AND CONDITIONS

1. This agreement starts on (DATE) between La Herrería Art Studio LLC, domiciled at (address) (email) (phone) represented by (name of director) , as the seller (representing Artist Fabian Perez), and (NAME) domiciled at (address) (email) (phone) as the client.
2. The client, (NAME), with shipping address (address), agrees to commission an Original Portrait Painting of his/her persona by Artist Fabian Perez, described below:

3. La Herrería Art Studio LLC, will provide framing for the artwork, shipping cost, duty fees, and customs. The artwork is insured by La Herrería Art Studio LLC in the event of any unexpected damage or loss during the shipping process. Direct Adult Signature will be required at the moment of delivery. See the full list of what is included as follows:

1. Your Masterpiece

Painted by Fabián Pérez at his studio in L.A., available in five sizes to choose from.

2. The Frame

The painting comes with a bespoke frame produced at Fabián's studio, offering two choices:

i. a dark frame with gold dots. ii. a 24-carat gold foiled frame.

3. The Photoshoot

Your photoshoot which includes hair, make up, designer and stylist, personally directed by Fabián, who will fly from L.A. to meet you at your desired address. Alternatively, you can provide us with your own photograph.

4. Photo Selection

Fabián will curate and choose the top 5 photos, which will be presented to you for your approval and final selection.

5. Logistics

Packing, shipping, shipping insurance, customs clearance, taxes and delivery of your commissioned masterpiece are included.

6. The Reveal Ceremony

Tailor-made for you and 10 of your loved ones, the reveal ceremony will include your masterpiece handover, photoshoot, drinks and dinner with Fabian. The venue, date and time will be coordinated between you and The Club.

7. Handover Photoshoot

Fabián will curate and choose the top photos which will be presented to you for your approval, final selection and inclusion in The Club Book of Living Legends.

8. The Club Book

You will receive ten copies of your personal edition of The Club Book. The book contains Fabián's portfolio of living legends portraits in one hundred pages, including four pages in the middle section of the book (Dignitaries, Royalty and Moguls), reserved and dedicated to you, featuring your photography, biography, your masterpiece portrait, reveal ceremony and handover photos with Fabián and any other information that you wish to include.

The Club Book is hard cover:

(18" x 14" Inches or 45 CMS x 35 CMS)

4. The terms of this agreement request the client to fulfil two payments for the artwork. The first payment of \$--,--- (50% of the artwork agreed price) to be made within 7 days of the invoice date, and it will serve as a deposit for the artist to keep the estimated production slot and to create the photo-shoot and to start working on the artwork. The second payment of \$--,--- is to be fulfilled within 7 days of the portrait completion notice by email, and prior to the shipping of the piece and prior to the Reveal Ceremony. Proof of completion will be sent in a form of a photo of your portrait next to Fabian. The full schedule as follows:

1. Fill out your masterpiece booking form.

2. Once your art work has been accepted and confirmed, we will send the sales agreement and invoice for payment of the first 50% deposit.

3. Once the payment has been received, we will coordinate and arrange the photoshoot at the earliest available date. Alternatively, you can provide us with your own photograph.

4. We will send us a photo of your finished portrait next to Fabian for the final payment. The portrait could take between 6 to 10 months to be completed depending on the number of portraits in queue. An estimated completion time will be stated on the invoice. An earlier production and completion time upon request.

5. Once the second payment has been received, we will coordinate with you the date and location of The Portrait Revelation Ceremony and the handover photoshoot.

6. With your information received and the ceremony photographs selection process concluded, we will print and deliver ten copies of The Club Book of Living Legends & Personalities to your desired address at the earliest available date or within 8 to 12 weeks.

5. All payments are to be made by Wire Transfer. Wire transfers should be sent to the following account:

6. The client understands that the artwork will be held in La Herrería Art Studio LLC offices until the termination of this agreement, when the total amount of of the artwork \$---,--- dollars is paid in full.
7. The client understands that this is a final sale; no returns, cancellations, or refunds are allowed within this agreement.
8. Artist Fabian Perez reserves the copyright to all works. No artwork may be reproduced by the client without prior written approval from the Artist.
9. The Artist agrees to finalise the Artwork within the period of (months) starting from the moment: (i) The first payment is received by La Herrería Art Studio LLC; (ii) The approval of the photo by the client. Once the photo has been chosen by email confirmation by the client, the work will start and the photo cannot be changed anymore.
10. Failure to make the stipulated payments described above will result in the cancellation of this Agreement.
11. The Agreement shall be governed by the law of The State of California, United States. Any judgements shall be enforceable in The State of California, United States.
